Correct data deletion is still a very neglected topic in many companies. Only half of all companies in Germany use a professional solution for the destruction of electronic data. Depending on the requirements, there are different possibilities to delete or destroy data carriers:

1. Software solutions

Since data media have existed, data leakage and data theft have repeatedly caused considerable damage to businesses. For some time now, reliable software solutions have been available that overwrite data carriers several times with different algorithms and thus delete the data irretrievably, even for specialists. Nevertheless, there are security gaps with these so-called software solutions that should be taken into account: Unfortunately, these solutions do not work with defective data carriers or magnetic tapes. However, defective data carriers are one of the greatest dangers when it comes to data leakage or data theft. At first glance, these seem safe, but in most cases specialists can still extract information. In order to eliminate this risk or to reliably delete all data, you need degaussers or shredders.

2. Degausser

The Degausser ensures complete demagnetization. The servo and maintenance information is also destroyed. Data carriers that have been degaussed are unusable after the process. Therefore, no degausser should be used if the mass storage devices are to be reused.

3. Shredder

The shredder ensures that your data carriers are physically shredded into tiny pieces. So you can be absolutely sure that your data is really 100 percent destroyed. K&P Computer has state-of-the-art mobile degaussing and shredding equipment especially for the destruction of hard disks and magnetic tapes. Thus all data irrevocable are destroyed after they have passed through our degaussers and shredders.

Protection class

We offer you our shredding process for the disposal of hard disks in accordance with DIN 66399, protection class 2, security level 4. This procedure is suitable for confidential data with a high need for protection, such as personnel and salary data, balance sheets, medical reports, tax documents or employment contracts.

Stationary Service

We destroy your sensitive data securely and reliably at our Headquarters in Wiesbaden. You are welcome to deliver your data carriers to us yourself or we can send a courier to bring your data carriers as GPS-monitored direct journey to our headquarters. Depending on your needs, we can also offer you this service on a mobile basis throughout Germany.

Mobile On-site-service

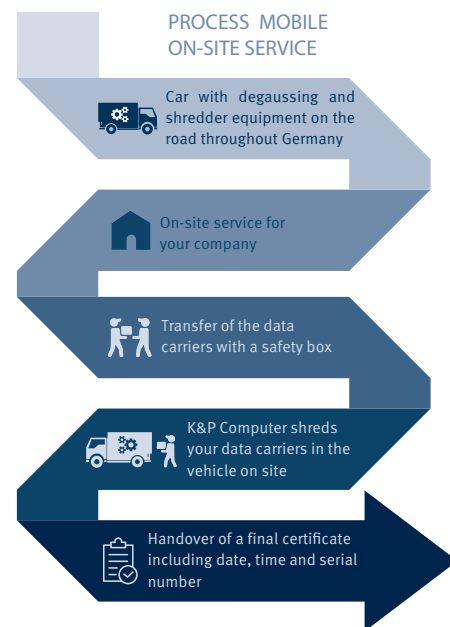
For the disposal of electronic data carriers, such as hard disks or magnetic tapes, we offer special lockable security boxes with unique identification. In this form of destruction, we ensure a continuous and recordable security chain. From the moment you place your hard disk in the lockable security box, the data is completely protected.

Our privacy-certified employees collect the electronic data carriers from the locked security boxes and take them to our mobile shredder vehicle. The data carriers are then immediately destroyed on site.

In order to comply with all data protection standards, we then issue a certificate about the destruction, stating date, time and clearly identifiable serial number. In this way, we guarantee the safe disposal of your electronic data carriers and all information contained on them.

Type of media

Apart from hard disk types of any kind (e.g. PATA , SATA , FATA) we also offer data destruction for the following media: All laptop types, desktop PCs, backup magnetic tapes (all types of DLT, LTO tapes, mini magnetic tapes, etc.) as well as optical data carriers (CDs, DVDs, Blu-ray and HD-DVDs).
